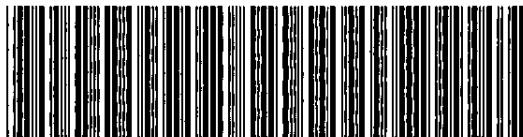

OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: MAUDY BROWN SCHOOL OF MINISTRIES AND ELIJAH INSTITUTE, INC. and its principal place of business is: 1445 NW 6th AVENUE FORT LAUDERDALE, FL 33311.

ARTICLE II
