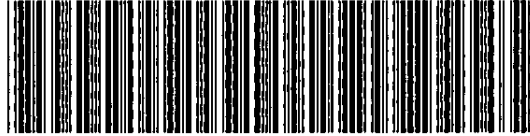

Articles of Incorporation Friends for Kids, Inc.

In compliance with chapter 617, F.S. (Not for Profit)

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify the following articles of Incorporation:

Article I: Name

The name of the Corporation shall be

Friends for Kids, Inc.

Article II: Primary Address

The primary place in this state where the principal office of the Corporation is to be located is

Boca Raton, Florida 33496

Article III: Purpose

This corporation is organized for the purpose of raising funds to provide toys and books for underprivileged children and to provide educational resources for their teachers in support of literacy. Said corporation is organized for charitable, educational, religious or scientific purposes, within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV: Manner of Elections

The Directors are appointed by the initial membership who will then appoint officers to be elected annually.

Article V: Duration

The corporation shall exist perpetually unless dissolved according to Florida law. Upon the dissolution, assets shall be distributed for one or more exempt purposes with the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Article VII: Corporate Powers

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article VIII: Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
