

Sewing New Futures, Incorporated

Article III. (revised)

The corporation is organized exclusively for charitable, and educational, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The mission of the incorporation is to empower women engaged in intergenerational prostitution and forced servitude through: education, medical services, and social services.

Article IX.

Upon the dissolution of the corporation, any property remaining after providing for the debts and obligations of the Corporation shall be distributed at the direction of the Board of Directors for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Article X.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article XI.

The Corporation reserves the right to amend, alter, change, or repeal any provision contained in these Articles Of Incorporation in such manner now or hereinafter prescribed by statutes or in the Bylaws, and all rights conferred upon directors and officers herein are granted subjects to this reservation.
