Amendment to Article III of the Articles of Incorporation Of

Model City Advisory Board Community Development Corporation

- a. The Model City Advisory Board Community Development Corporation will provide training for job opportunities throughout our community. It will target the High unemployment rate and poverty in our community called the urban crisis and gun violence.
- b. The Model City Advisory Board Community Development Corporation is organized to provide services to our community as an exempt organization to qualify under Section 501(c)(3) of the Internal Revenue Code. No part of the net earnings of the Model City Advisory Board Community Development Corporation shall benefit or be distributed to it's members, trustees, Officers, or any other private persons, except that Model City Advisory Board Community Development Corporation shall be authorized and empowered pay reasonable compensation for services rendered and to make payments and distributions to furtherance of the purposes set forth in the purpose of clause set hereof. No substantial part of the activities of Model City Advisory Board Community Development Corporation shall be carrying on the propaganda, or otherwise attempting to influence legislation, and the shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document. Model City Advisory Board Community Development Corporation shall not operate for any other Purposes not permitted to be carried on (a) by an organization exempt from federal Income tax under Section 501@(3) of the internal Revenue Code or corresponding section of any future federal tax code.
 - c. Upon the dissolution of the Model City Advisory Board Community Development Corporation assets shall be distributed for one or more exempt purposes within the Meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, state, or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the court of common pleas of the county in which the principle office of the Model City Advisory Board Community Development Cooperation is then located, exclusively for Such purposes or to such organization or organizations, as said Court shall determine, Which are organized and operated exclusively for such purposes.
