**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
SHALOM LIFE CENTER, INC.**

Shalom Life Center, Inc., a not-for-profit corporation (the "Corporation"), organized and existing under the laws of the State of Florida, filed on May 20, 2015, hereby certifies as follows:

Pursuant to the unanimous written action of all of the Directors of the Corporation, in lieu of a special meeting, the following resolution was adopted on the 9 day of July 2015, amending the Articles of Incorporation:

RESOLVED, that Article 7 of the Articles of Incorporation filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

"ARTICLE 7 – OFFICERS

The officers of the Corporation shall be a President, Vice President, Secretary and Treasurer, and such other officers as may be provided by Bylaws adopted for the Corporation. Officers shall be elected by the Board of Directors in the manner set forth in Bylaws adopted for the Corporation. The following people are hereby elected to the respective offices to serve until the next annual meeting or until a successor or successors are elected and qualified:

Vice President/Secretary/Treasurer:	Marvin Rappaport

WHEREUPON, at Fort Myers, Florida on this 9 day of July 2015, the Corporation hereby certifies accordingly, under its corporate seal and the hand of its President, so that, on the filing hereof, the Articles of Incorporation shall be deemed amended accordingly.
