ARTICLES OF INCORPORATION for

RENOVATE LIFE, INC.

ARTICLE I

NAME

SECRETARY OF STATE

1.01 Name

The name of this not-for-profit corporation shall be Renovate Life, Inc. The business of the corporation may be conducted as Renovate Life, Inc.

ARTICLE II

DURATION

2.01 Duration

The period of duration of the corporation is perpetual or until such time as the Board of Directors shall adopt a resolution recommending that the corporation be dissolved pursuant to Florida law.

ARTICLE III

PURPOSE

3.01 Purpose

Renovate Life, Inc. is a not-for-profit corporation and shall operate exclusively to charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code, including but not limited to: helping abused women and children to restart their lives by assisting and providing the resources that is need to do so, educating on abuse and moving forward, advocating for women and children and the various forms of abuse and conducting research.

Renovate Life, Inc.'s purpose is to assist abused women and children to restart their lives, by providing the resources that is necessary to accomplish that goal. Referrals for some the agencies are as follows, but are not limited to: lawyers, therapists, and employment agencies. Also, Renovate Life, Inc. will have a trained assistant that will be matched to each family or individual, so that the victims will have a personal contact to assist them in any immediate and necessary area of reclaiming their new start in life.

Renovate Life, Inc. will be the avenue to fulfill all areas of women and children's new start in life.

3.02 Public Benefit

Renovate Life, Inc. is designated as a public benefit corporation.

ARTICLE IV

NON-PROFIT NATURE

4.01 Non-profit Nature

Renovate Life, Inc. is not organized for profit, and no part of the net earnings of this corporation shall inure to the benefit of any member of the Board of Directors or any other individual except that this corporation may make payments of reasonable compensation for services rendered.

The corporation shall not participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office to an extent that would disqualify it from tax exemption under section 501(c)(3) of the Internal Revenue Code. The corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.

Notwithstanding any provision of these Articles of Incorporation, this corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States internal revenue law).

Renovate Life, Inc. is not organized and shall not be operated for the private gain of any person. The property of the corporation is irrevocably dedicated to its charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual.

4.02 Personal Liability

No officer or director of this corporation shall be personally liable for the debts or obligations of Renovate Life, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

4.03 Dissolution

Upon termination or dissolution of Renovate Life, Inc. any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code or described in any corresponding provision of any successor statute) which organization or organizations have a purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of Renovate Life, Inc. hereunder shall be selected by the discretion of a majority of the managing body of Renovate Life, Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against Renovate Life, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a social welfare purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

4.04 Prohibited Distributions

No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

4.05 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.06 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V

STOCK

5.01 No capital stock

This corporation shall have no authority to issue capital stock

ARTICLE VI

BOARD OF DIRECTORS

6.01 Governance

Renovate Life, Inc. shall be governed by its board of directors.

6.02 Initial Directors
