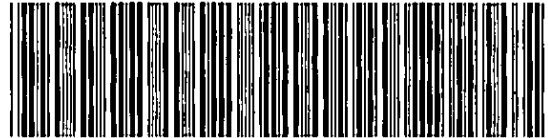




Article IX
