ARTICLE I NAME

The name of the corporation shall be: Faith-Based Leaders on Watch, Inc.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: to work with faith-based organizations and community organizations to promote sustainable programs for youth in Miami-Dade County, especially in the Liberty City area neighborhoods, that will promote positive changes in the affected areas.

B. This organization is organized exclusively for religious, charitable, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

C. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed: by a majority of the members present at such meeting, provided that there is a quorum present at the meeting.
