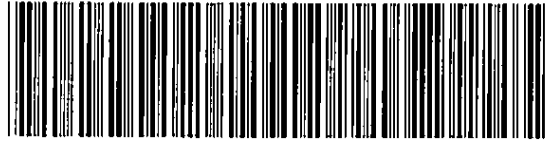

Pursuant to Section 617.1006, Florida Statutes, this Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The following amendment to the Articles of Incorporation of this Corporation was duly adopted by the Corporation on December 19, 2023 at a duly noticed meeting of the Members of the Corporation at which a quorum of the Members of the Corporation were present in person or by proxy. The number of votes cast by the Members for the following amendments was sufficient for approval of the Amendments pursuant to the terms of Article XI, Subsection B of the Articles of Incorporation of the Corporation.

2. The existing **ARTICLE IV, MEMBERSHIP** is deleted in its entirety and amended to read as follows:

**ARTICLE IV**  
**MEMBERSHIP**

Every person or entity who is a record owner of a fee or undivided fee interest in any Unit or Lot located within any of the following subdivision Plats as previously recorded in the Public Records of Sarasota County, Florida:

1. PARK FOREST, PHASE 6A, as per Plat thereof recorded in Plat Book 48, Page 10 of the Public Records of Sarasota County, Florida, and
2. PARK FOREST, PHASE 6B, as per Plat thereof recorded in Plat Book 49, Page 31 of the Public Records of Sarasota County, Florida, and
3. PARK FOREST, PHASE 6C, as per Plat thereof recorded in Plat Book 50, Page 47 of the Public Records of Sarasota County, Florida, and
4. PARK FOREST, PHASE 6D, as per Plat thereof recorded in Plat Book 50, Page 50 of the Public Records of Sarasota County, Florida

including contract sellers, shall be a Member of the Association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership is appurtenant to and inseparable from ownership of the Unit or Lot.
