

Amended Article I: The name of the corporation shall be Little Birthday Angels, Inc. (the "Corporation"). Said corporation is organized exclusively for charitable, Christian (bible-based principles), educational and scientific purposes including for purposes the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).

Amended Article VI: The corporation shall be perpetual. Upon the dissolution of this non-profit corporation assets shall be distributed for one or more exempt purposes within the meaning of the section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the Federal government. Any such assets not so disposed of shall be disposed of by the Board of Directors of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as the Board of Directors shall determine.
