ARTICLES OF INCORPORATION

ARTICLE I: NAME

The name of the corporation is **Smiley Medical Research International Foundation Inc.**

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

ARTICLE X: AMENDMENTS

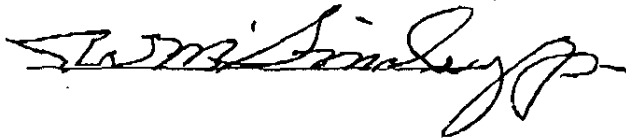
The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
