

Articles of Incorporation of Go N Give It, Incorporated

Article I - CORPORATE NAME

The name of this corporation is Go N Give It, Incorporated.

Article II - CORPORATE NATURE

This is a non-profit corporation, organized solely for educational and charitable purposes pursuant to the Florida Corporations Not-For-Profit Law set forth in Section 617 of the Florida Statues.

The principal place of business and mailing address of the corporation is 1025 W. Indiantowir Road, Suite 106, Jupiter, Florida 33458.

Article III -- DURATION

The term of existence of the corporation is perpetual.

Article IV - PURPOSES

Pursuant to Chapter 617 of the Florida Statues, this non stock basis corporation is organized as a not-for-profit corporation exclusively for educational, charitable, and social purposes as described in Section 501(c)3 of the Internal Revenue Code. The specific purpose or purposes for which the corporation is organized are to mentor and provide life enrichment skills to youth and young adults, education young people on the importance of education and pursuing their life goals and dreams, and provide support and assistance to youth and young adults desiring to attend college.

Article V - MEMBERSHIP

The authorized number and qualifications of members of this corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members shall be set forth in the By Law.s

Article VI -INITIAL OFFICE AND REGISTERED AGENT

Article VII - DIRECTORS

A. The Board of Directors shall consist of the number of directors set forth in the By Laws but shall not be less than five directors.

On the dissolution of the Corporation, its assets and liabilities of this Corporation, shall be distributed to a non-profit fund, foundation, or Corporation which are organized and operated exclusively for educational and charitable purposes and which has established its tax exempt status under Section 501(c)3 of the Internal Revenue Code.

Article IX - CHARITABLE RESTRICTIONS AND LIMITATIONS

- A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.
- B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign for or against any candidate for public office.
- C. Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by:
 - 1. A not for profit corporation under Chapter 617 of the Florida Statues, or any other corresponding provision of any future Florida Statue; or
 - 2. Any corporation, contributions to which are deductible under Section 170(c)(2) of the internal Revenue Code or corresponding section of any future tax code; or
 - 3. A corporation exempt from federal income tax under Section 501(c)3 of the Internal Revenue Code or corresponding section of any future Federal Tax Code.

Article X - INCORPORATOR
