ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S., (Not for Profit)

Articles of Incorporation of Central Music Boosters, Inc.

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation, do hereby certify:

ARTICLE I NAME

The name of the corporation shall be: Central Music Boosters, Inc.

ARTICLE II PRINCIPAL OFFICE

6180 Central School Road, Milton, FL 32570

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: to provide financial support and volunteer assistance to meet the needs of the Central Music activities as directed by the Central Music Director for which instruction and education in these activities is provided to the students of Central School, Milton, Florida. To achieve this objective, the CMB shall: provide the ways and means of organized fund raising events. Funds raised from such events shall be utilized entirely for the operations of the Central Music Program; and provide volunteers to assist Central School Music in the preparation and operation of performances, educational camps and other such activities conducted by the Central Music Program. This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected and appointed: At each annual meeting, the Regular CMB Members shall determine the number of Board of Directors Members to be elected for the ensuing year and shall elect such number of Board Members. The number so fixed may be increased at any regular or special meeting of the Members, and if the number is increased, the additional Board of Directors Members may be elected at the meeting at which the increase is voted, or at any subsequent meeting. All elections of Board Members shall be by majority vote of all members present or represented by a properly executed and signed absentee ballot filed with the Nominations Committee of the CMB prior to the election meeting.

ARTICLE VI

In accordance with Section 501(c)(3) of the Federal Internal Revenue Code, the CMB shall operate exclusively as a non-profit organization providing financial support and volunteer assistance to the Central School Music activities. No part of the net earnings of the CMB shall inure to the benefit of, or be distributable to, its directors, officers, members, or private persons, except that the CMB shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its exempt purposes. Except as otherwise provided by Section 501(h) of the Code, no substantial part of the activities of the CMB shall consist of carrying on propaganda, or otherwise attempting, to influence legislation. The CMB shall not participate

in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. Notwithstanding any other provision of these articles, the CMB shall not carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code, or (b) by any organization contributions to which are deductible under Section 170(a) of the Code as being to an organization referred to in Section 170(c)(2) of the code.

ARTICLE VII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

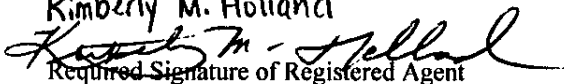

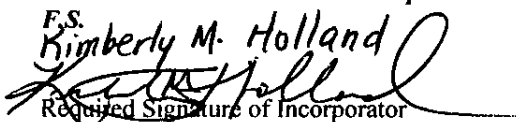
