TO THE  
ARTICLES OF INCORPORATION  
OF

Pursuant to Sections 617.1001 and 617.1002 of the Florida Not For Profit Corporation Act, **FIRESTARTER FUND, INC.**, a Florida not-for-profit corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **FIRESTARTER FUND, INC.**
2. The document number of the Corporation is N15000005827, the effective date of filing the Articles of Incorporation with the Florida Department of State was June 3, 2015.
3. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety as follows:

**ARTICLE I:** The name of the Corporation is:

**FIRESRING FUND, INC.**

4. Subject only to the foregoing amendment to Article I, the Articles of Incorporation of the Corporation shall be and remain in full force and effect.
