Amended ARTICLES OF INCORPORATION

Articles of Incorporation of the Student Services Society. The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

- 1. The name of the Corporation shall be Student Services Society.
- 2. The place in this state where the principal office of the Corporation is to be located is the City of Coral Springs, Broward County.
- 3. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The mission and objectives of the Corporation are:

Organization General Mission Statement

The mission of this organization is to provide aid and assistance to post elementary/ middle school individuals seeking higher education who need assistance with current student related problems or those who have unresolved problems stemming from their higher education experience through consultation, economic assistance, aid and assistance in legal affairs.

Specific Objectives

The specific objectives of the organization include, but are not limited to:

- 1. to buy student loan debt and pair up with debt relief organizations like Strike Debt;
- 2. develop a pay it forward program for those who have used the organization's services:
- 3. develop our own type of 'fund me' style program for students and student loan debtors;
- 4. work with other public action organizations on targeted objectives and petitions related to student debt, curricula, and other issues;
- educate students on options to debt financing through activities including, but not limited to, events, seminars, radio, electronic media and television shows, and advertising;
- 6. maintain data banks on law suit decisions and briefs that would help students seek judicial debt relief;
- 7. aid in the prosecution of law suits that will broaden the opportunity for student loan debtors to seek bankruptcy or other relief;
- 8. hold revenue raising events, including fairs, book sales, fund raising campaigns and membership drives, and use the proceeds to provide scholarships to student volunteers and serve the needs of the organization;

- 9. educate the community at large and public policy makers of conditions that need changing to help the student and post student population improve their lives and raise the general standards of living. "How to make education rewarding for each individual and the community;"
- assist with the development of mental health programs for persons who feel their education has cheated them or age and education have denied them reasonable opportunities;
- 11. develop an "Enterprise Emergence" program for the organization's target groups to help transition them from an educational activity to business and life development activities through:
 - A. the establishment of a network of professionals to develop marketing/ advertising, business plans and budgets, web pages and tools, public relations, finance, e-books, white pages, and other useful tools;
 - B. critiquing of and/or developing a business plan and budget for their business;
 - C. providing assistance with job placement for older more mature persons;
- 12. other objectives as established by the Board and Executive Director.

- 5. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 6. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
