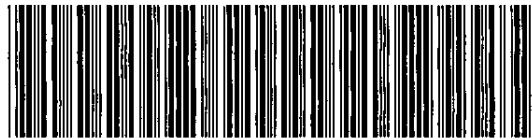

The undersigned does hereby act as incorporator for the purpose of forming a corporation under the Florida General Not For Profit Corporation Act, as amended from time to time.

FIRST: The name of the corporation (hereinafter called the "**Corporation**") is

THIRD: The purposes of this Florida Not For Profit Corporation are to

- (c) To promote justice and universal respect for human rights and fundamental freedoms;

SEVENTH: The personal liability of the Directors of the Corporation is eliminated to the fullest extent permitted by the provisions of the Florida General Not for Profit Corporation Act, as the same may be amended and supplemented.

EIGHTH: Distribution. In the event of the dissolution of this corporation, the Board of Directors shall, after paying or making any provision for the payment of all of the liabilities of the corporation to be distributed as follows: (a) to the Zonta International Foundation (b) to any other entity, which shares a similar purpose and is exempt as a 501(c)(3) organization under the Internal Revenue Code or (c) for exempt purposes or to the federal, state, or local government for a public purpose. Any of such assets not so distributed shall be as distributed by the Circuit Court of the County in which the principal office of the Corporation is then located.

NINTH: The effective date for Articles of Incorporation shall be June 1, 2015
