ARTICLES OF INCORPORATION OF Zonta Club of Sanibel-Captiva, Inc.

The undersigned does hereby act as incorporator for the purpose of forming a corporation under the Florida General Not For Profit Corporation Act, as amended from time to time.

<u>FIRST</u>: The name of the corporation (hereinafter called the "**Corporation**") is

Any of such assets not so distributed shall be as distributed by the Circuit Court of the County in which the principal office of the Corporation is then located.
