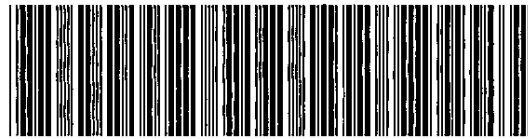

Article III - Purpose
