The undersigned, for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, do hereby make and adopt the following Articles of Incorporation:

#### ARTICLE I.

# Name and Mailing Address

The name of the corporation shall be The Gase Family Foundation, Inc. The mailing address for the corporation is 3541 Crest Street, St. Augustine, Florida 32092.

# ARTICLE II.

# Not For Profit

This is a corporation not for profit within the meaning of Chapter 617, Florida Statutes. The corporation is not formed for pecuniary profit.

#### ARTICLE III.

#### **Duration**

The duration of the corporation is perpetual, unless otherwise provided in the by-laws.

### ARTICLE IV.

### <u>Purposes</u>

The corporation is organized exclusively for charitable, religious and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, including for such purposes the making of distributions to organizations qualified under said Section 501(c)(3).
