ARTICLES OF INCORPORATION FOR GLORY FILLED ASSEMBLY INC.

The undersigned person acting as incorporator of a corporation not for profit under the Florida Not for Profit Act, as set forth in Chapter 617 of the Florida Statutes adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the corporation is GLORY FILLED ASSEMBLY INC.

ARTICLE II

The corporation shall have a perpetual duration.

ARTICLE III

The specific purposes for which the corporation is organized are:

- 1) To spread the message of Jesus Christ through preaching and encourage a Christ centered life.
- 2) To mentor children and young adults.
- 3) To provide Christian life services to families.
- 4) To provide encouragement/services for the elderly.
- 5) To operate exclusively in any other manner for such religious, charitable, and educational purposes as will qualify it as an exempt organization under Section 501 of the Internal Revenue Code, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.

ARTICLE IV

The corporation is organized upon a non-stock basis as defined in Section 617.011 of the Florida Statutes. The corporation shall have a membership distinct from the board of directors.

ARTICLE V

The street address of the initial registered officer of the corporation is 109 N. Armenia Avenue, Tampa, Florida 33609. The name of its initial registered agent is Fehintola Oguntebi.

ARTICLE VI

The powers of this corporation shall be exercised, its property controlled and its affairs conducted by a board of trustees. The number of trustees of the corporation shall

be three (3) provided however that such number may be changed by the bylaws of the corporation. Election of board of trustees shall be as stated in the bylaws of the corporation.

Board members shall individually or collectively consent in writing to any action required or permitted to be taken by the board. Such written consents shall be filed with the minutes of the proceedings of the board, and any such action by written consent shall have the same force and effect as if taken by unanimous vote of the trustees. Any certificate or other document filed under any provision of law that relates to action so taken shall state that the action was taken by unanimous written consent of the Executive Board of Trustees without a meeting and that the Articles of Incorporation of this corporation authorize the trustees to so act. Such a statement shall be prima facie evidence of such authority.

ARTICLE VII

Subject to the limitations contained in the bylaws and any limitations set forth in the Not For Profit Corporation Act of Florida described above, concerning corporate action that must be authorized or approved by the members of the corporation, the bylaws of this corporation may be made, altered, rescinded, added to, or new bylaws may be adopted, either by a resolution of the board of directors or by following the procedure set forth therefore in the bylaws.

ARTICLE VIII

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director or officer of the corporation.

ARTICLE IX

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be

distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for religious, educational and professional purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

ARTICLE X

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of members for their vote. Amendments may be adopted by a vote of a quorum of members of this corporation.
