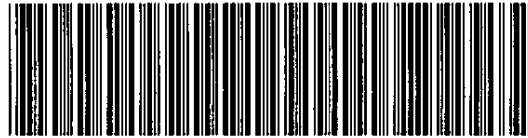

ARTICLE OF INCORPORATION
OF
BLESSING REBUILDING ASSISTING NEEDS CHANGING HEARTS,
(B.R.A.N.C.H) Inc.

In compliance with the requirements of Florida Statutes, Chapter 617, the undersigned serves as incorporator, for the purpose of forming a corporation not-for-profit and does hereby certify:

ARTICLE I
NAME OF CORPORATION

The name of the corporation is Blessing Rebuilding Assisting Needs Changing Hearts, Inc. (hereinafter called B.R.A.N.C.H).

ARTICLE II
PRINCIPAL OFFICE OF THE CORPORATION

The principal office and mailing address of B.R.A.N.C.H shall be 2624 Robert Trent Jones Drive #621, Orlando, FL 32835

ARTICLE III
PURPOSES AND POWERS OF THE CORPORATION

B.R.A.N.C.H does not contemplate pecuniary gain or profit to its members, and the specific purposes for which it is formed are:

(1) exclusively for charitable, educational, religious and/or scientific purposes within the meaning for Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or under any corresponding provisions of any subsequent federal tax laws governing the distributions to organization qualified as tax-exempt; and

(2) except as limited by the Articles of Incorporation and the Bylaws, B.R.A.N.C.H will have and exercise all rights and powers in furtherance of its purposes as are or may hereafter be conferred on not for profit corporations pursuant to Chapter 617, Florida Statutes, and in accordance with other applicable law.

Notwithstanding any other provisions of these Articles of Incorporation, B.R.A.N.C.H shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV
MANNER OF ELECTION

The affairs of this B.R.A.N.C.H shall be managed by its Board of Directors. The method of election or appointment of the Board of Directors shall be fixed and governed by the Bylaws of B.R.A.N.C.H.

DISSOLUTION

A majority of the Board of Directors may authorize dissolution of B.R.A.N.C.H. After dissolution is authorized, B.R.A.N.C.H must file articles of dissolution, in compliance with Section 617.1403, Florida Statutes, with the Department of State.

Upon the dissolution or winding up of B.R.A.N.C.H, its assets remaining after payment, or provision for payment, of all debts and liabilities of B.R.A.N.C.H, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.
