The name of this corporation shall be **SACRED SOIL INC.**

The principal office of this corporation shall be 2707 KILLARNEY WAY, TALLAHASSEE, FL 32309

#### ARTICLE III

The general nature of the objects and purposes of this corporation shall be:

- A. The Sacred Soil, Inc is organized exclusively for CHARITABLE, RELIGIOUS AND EDUCATIONAL purposes within the meaning of section 501(C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. This organization is not organized for the private gain of any person. It is organized under the NON-PROFIT CHARITABLE AND EDUCATION CORPORATION LAW exclusively for religious, charitable and educational purpose.
- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- C. The specific purpose of this corporation is to create and enhance educational, social and economic opportunities and development in communities located in Leon and Gadsden County, Florida and throughout the state of Florida.
- D. To acquire title to real property and personal property either by purchase, gift or otherwise as owned in fee simple.
- E. To buy, own, hold, contract, improve, mortgage, rent, lease, sell, convey, and otherwise acquire and dispose of real, personal, or mixed property or any rights, interest, or any estate therein as owner or otherwise.
- F. To construct, build, repair, maintain, operate, and lease buildings or other improvements on property owned or controlled by said corporation.
- G. To borrow money and contract debts, issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidence of indebtedness payable at specific time or event, whether secured by mortgage, pledges or otherwise, secured
