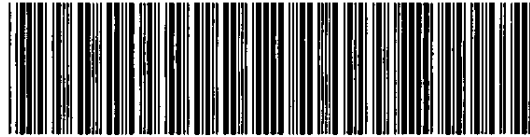



**Articles of Incorporation
of
The Edward and Garnell Jenkins Center for Social Justice, Inc.**

**Article I.
Name**

The name of the corporation not for profit is The Edward and Garnell Jenkins Center for Social Justice, Inc.

**Article II.
Principal Office**

The principal office of the corporation is 1501 16th Street South, St. Petersburg, FL 33705. The mailing address of the corporation is 1501 16th Street South, St. Petersburg, FL 33705.

**Article III.
Purpose**

A. The purpose of The Edward and Garnell Jenkins Center for Social Justice, Inc., is to maintain the property located at 1501 16th Street South, St. Petersburg, FL, in perpetuity for use as a locally controlled community resource, and to make this resource available at cost to other cooperating civic organizations focused on the betterment of the community, including specifically, any local chapter of the NAACP, Inc. In so doing, the corporation will strive to improve the political, educational, social and economic status of minority groups; to eliminate racial prejudice; to inform the public of the adverse effects of racial discrimination; and to take all lawful action in the furtherance of these objectives.

B. The purposes of The Edward and Garnell Jenkins Center for Social Justice, Inc., a corporation not for profit, are exclusively charitable under 26 U.S.C. § 501 and Fla. Stat § 617.

C. No part of the assets or net earnings of the corporation shall inure to the benefit of any private shareholder or individual.

D. Notwithstanding any other provision of these articles, the corporation shall not conduct or carry on any activities prohibited by 26 U.S.C. § 501(c)(3).

**Article IV.
Board of Directors**

The board of directors shall be elected as stated in the corporation bylaws. Notwithstanding any bylaw provision, the board elections shall be staggered such that no more than a minority of board members may be elected in any single regular election.

**Article V.
Initial Officers**

**Article VI.
Dissolution**

A. Should the corporation cease to exist, on dissolution, no asset of the corporation will inure to the benefit of any private shareholder or individual.

B. On dissolution, the board of directors shall distribute the property located at 1501 16th Street South, St. Petersburg, FL, to a government entity or locally controlled corporation not for profit, for perpetual use as a locally controlled community resource. All other corporation assets may be distributed to any government entity or corporation not for profit, for the benefit of the community.

C. For the purposes of asset distribution on dissolution, a quorum shall be 2/3 of the members of the board of directors, with a majority of voting directors required to pass title of corporation assets.


**Article VII.


