IPSA Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows:

- 1. Sponsor young, talented players from low-income families who otherwise could not afford the high fees for local clubs
- 2. Subsidize training for up to 140 IPSA Cadets -- our new program designed to introduce novice U6 -- U9 players to the sport and begin developing their skills and technique in a fun environment
- 3. Fund our high school players -- college preparatory courses and college visitation trips, and gather game footage for their college recruiting

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervenc in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.
