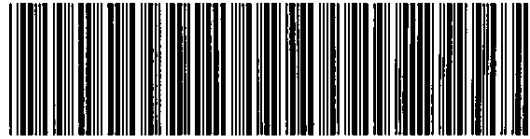

ARTICLES OF INCORPORATION
OF
HOME IN THE HEART FOUNDATION, INC.

The undersigned, acting as incorporator of a not-for-profit corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is: HOME IN THE HEART FOUNDATION, INC.

ARTICLE II

The street address of the initial principal office of the corporation shall be 518 Riverside Drive, Tarpon Springs, Florida 34689, and the mailing address of the corporation shall be 518 Riverside Drive, Tarpon Springs, Florida 34689.

ARTICLE III

The purpose for which this not-for-profit corporation is organized is to:

reach and assist many sectors of the populace in coming to higher awareness and higher life expression;

foster peace and solidarity in families, communities, and in the world;

alleviate suffering and conflicts in individuals, families, communities, and the world by fostering emotional and relationship growth and harmony;

address core issues of human suffering brought about by separation from a fulfilling and loving spiritual life;

provide materials and services to transcend current religious, educational, social, and economic boundaries that impede a heart-centered life filled with love, acceptance, and harmony; and,

empower each person, as a fully alive and flourishing individual, to share his or her gifts and talents in the world.

Notwithstanding any of the foregoing statements of purposes, this corporation shall only engage in activities or exercise powers that are permitted by an organization exempt from federal income tax under Section 501(c)(3) of the United States Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE IV

The method of election of directors shall be as stated in the bylaws.

ARTICLE V

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes.

ARTICLE VI

The initial registered office of the corporation shall be located at 518 Riverside Drive, Tarpon Springs, Florida 34689. The initial registered agent of the corporation at that address shall be ANN MARIE NIELSEN.

ARTICLE VII

The name and address of the incorporator is as follows: ANN MARIE NIELSEN, 518 Riverside Drive, Tarpon Springs, Florida 34689.

ARTICLE VIII

a. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, directors, trustees, governors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

b. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

c. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by such an organization exempt from federal income tax under Section 501(c)(3) of the United States Internal Revenue Code or corresponding section of any future federal tax code, or by such an organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

d. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the circuit court of the county in which

the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

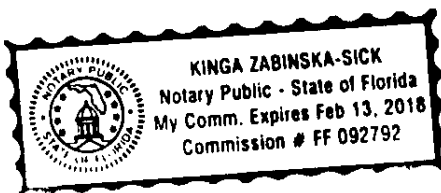



