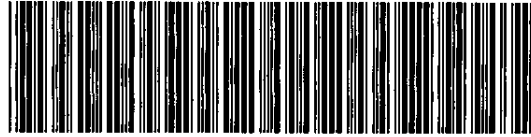



Special emphasis will be on serving under privileged youth and adults from diverse backgrounds, key objectives of all programs is to strengthen our community through career development, leadership, cooperative learning, elevating self-esteem and fostering multi-cultural exchange. Our program will recruit and train early education for the underprivileged who has been excluded from the traditional pathways to career formation and advancement by protracted poverty. Our program will work with life management, social skills, and literacy for low-income, youth and adults that are underserved, handicapped, under privileged, disenfranchised and disadvantaged. **The Corporation** is to offer services that expose, educate, research, document, collect, interpret and preserve for community enrichment and empowerment. Our goal is to provide each youth and/or adult with knowledge and resources to achieve greater self-identity, academic excellence, community involvement and balanced living. Our program gives the youth and adults in our community a place to come and learn about life challenges in academic excellence by introducing principles and skills that increase their confidence and intellectual capabilities. The program focus on specific performance indicators with such measurable results as literacy research, rehabilitation, outreach activities, crisis counseling, education, self-sufficiency values, pre- employment training for young adults, along with general counseling and mental depression participation.
