The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation and acting as incorporator of a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

Article I

The name of the corporation is Rise Up Young Church, Inc.

Article II

The address of the Corporation's principal office is 1050 Talleyrand Avenue, Jacksonville, Florida 32206 in the County of Duval.

Article III

The purpose for which this Corporation is formed are exclusively charitable, religious and educational in nature including but not limited to the following:

- 1. To provide transformational experiences in order for young people to connect, activate and share their faith in God.
- 2. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining the foregoing purposes, either directly or indirectly, and either alone or in conjunction or in cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations or governmental bureaus, departments or agencies.
- 3. All of the foregoing charitable and religious purposes shall be exercised in such a manner that the Corporation will qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.

Article IV

The number of directors shall be set forth in the bylaws of the Corporation. The method of selecting the Directors shall be set forth in the bylaws.

Article V

The names of the initial Board of Directors are:

Nancy M. Powers, President / Treasurer Oneilia Lee, Vice President / Secretary Reverend Jason C. Trull, Chaplain / Advisor

Notwithstanding any other provision of these articles this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and State income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law.

Article VI

The registered agent at this address is Nancy M. Powers, 1050 Talleyrand Avenue, Jacksonville, Florida 32206 in the County of Duval.

Article VII

The name and address of the incorporator is Nancy M. Powers, 1050 Talleyrand Ave., Jacksonville, FL 32206 in the County of Duval.

Article VIII

The period of duration is perpetual. The Corporation is organized pursuant to applicable Not For Profit Corporation laws of the State of Florida. The qualification for members, if any, and the manner of their admission shall be regulated by the bylaws.

Article IX

The Corporation is organized exclusively for charitable and religious purposes. Therefore, no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. The property, assets, profits and net income of the Corporation are irrevocably dedicated to the charitable and religious purposes and no part of which shall inure to the benefit of any individual.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal

income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article X

Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code to be used exclusively for charitable and religious purposes. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article XI

In the event that this Corporation shall become a "private foundation" within the meaning of section 509 of the Internal Revenue Code, the Corporation shall distribute its income for each taxable year at such time and in such manner as not to subject it to tax under section 4942 of the Internal Revenue Code; shall not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code; shall not make any investments in such manner as to subject it to tax under section 4955 of the Internal Revenue Code; and shall not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code.

Article XI

Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he/she is or was a Director or Officer of the Corporation shall be indemnified of the expenses, including attorney's fees and disbursements, incurred by him/her (or by his/her heirs, executors or administrators: in connection with the defense of settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his/her duties. Such right of indemnification shall not be deemed exclusive or any other rights to which such Director or Officer (or such heirs, executors or administrators) may be entitles apart from the Article.

Article XII

Rise Up Young Church was established on June 24, 2015, the Feast Day of St. John the Baptist. These Articles of Incorporation were approved and are hereby executed by the incorporator on this 30th day of June, 2015.
