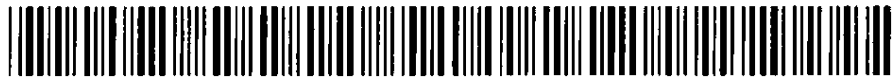

NOTICE OF CORPORATE DISSOLUTION


