#### Tap The App Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: It is being created to support and promote Digital Literacy in America. It seeks to recycle, build and purchase computers and software for redistribution to family, schools, churches and other institutions in need of computers and internet access.
