ARTICLE I NAME and ADDRESS

The name of the corporations shall be: Tambores de Colombia Int'l Charitable Fund, Inc.

The mailing address of the corporation shall be: 16751 NW 89 Place, Miami Lakes, FL. 33018

ARTICLE II TERM OF EXISTENCE

The corporation is to exist perpetually.

ARTICLE III PURPOSES

The general purpose of the organization will be to operate a charitable organization within the meaning of Section 501(C) (3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law thereto. The Specific purpose for which this organization is being created is to provide children living in extreme poverty with the opportunity to receive a quality education. As well as, strive to provide children and adults with music and cultural exchange as a form of therapy for medical and psychological rehabilitation.

ARTICLE IV

POWER

This corporation shall have power to purchase, own, hold, and build upon. Rent and/or lease property, real, personal and mixed; to receive the gift, devise or bequest property of any character whatsoever and no matter where situated, to sell, convey, mortgage and otherwise dispose of any property in any manner, acquire by it, and at any time, to contract, sue and be sued in its corporate name; to have a corporate seal should it so desire; to indemnify its directors and officers, to adopt, amend, repeal or alter such bylaws as its Board of Directors may, from time to time, hereafter adopt, and in general, to do any and all things as may be necessary or proper to carry out the objectives and purposes for which this corporation informed, and as may be permissible by laws governing non-profit corporations in the State of Florida.

ARTICLE V BOARD OF DIRECTORS

Except as limited by the Articles of Incorporation the affairs of this corporation shall be managed and its corporate powers exercised by the board of Directors. Each Director shall be appointed and may be removed by the Board of Directors by vote.

ARTICLE VI ADDITIONAL BOARDS

The corporation shall also have a non-governing Advocacy Board, whose member shall be appointed and may be removed by the Board of Directors and whose duties shall be identified and descried in the bylaws of the corporation.

ARTICLE VIII BYLAWS

The bylaws of this corporation shall be adopted, modified, or repealed by the Board of Directors.

ARTICLE IX AMENDMENTS

These Articles of Incorporation may be amended by the Board of Directors of the corporation at any regular or special meeting called by the Board of Directors for that purpose.

ARTICLE X CONDUCT OF AFFAIRS

The business and affairs of Incorporation shall be conducted in a manner consistent with the provisions of the Articles of incorporation and bylaws of the corporation. The Board of Directors shall consist of at least four (4) members at all times who have outside business relationship other than the conduct of the affairs of this any others organization exempt from tax under section 501 (C) (3) of the Internal Revenue Code of 1986.

ARTICLE XI LIMITATION ON ACTIVITIES

The purposes for which the corporation is organized are: to operate exclusively for charitable, educational and music therapy purposes within the meaning of Section 501 (3) (C) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States International Revenue law thereto, and such purposes shall include and be limited by the following:

TAMBORES DE COLOMBIA INT'L CHARITABLE FUND, INC. is not organized for pecuniary gain or profit, nor shall it have the power to issue certificates of stock or declare dividends and, no part of the net earnings of the corporation shall inure to the benefit of, or be

distributed to, its directors officers, or any other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation. No substantial part of the activities of the corporation shall be carrying on the propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt for Federal Income Tax under section 501 (C) (3) of the Internal revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), or a corporation, contribution to which are deductible under Sections 170 (C) (2) and 509 (a) (1) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law.

ARTICLE XII DISTRIBUTION OF ASSETS UPON DISSOLUTION

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization all of its assets remaining after payment of all cost and expenses of such dissolution shall be distributed to organizations selected by the Board of Directors which have qualified for exemption under Section 501(C)(3) and 170 of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law, and none of its assets will be distributed to any officer, or director of this corporation, or any other private purpose or enterprise. The corporation may confer benefits in the form of distributions, in dissolution or otherwise, upon a not-for-profit corporation described in Section 501(c) (3) of the internal Revenue Code of 1986 who has been recognized by the IRS as 501 (c) (3) organization.
