- 2. Breaking The Cycle Institute, Inc. is an educational organization specifically dedicated to engaging individuals families and communities to promote solutions to breaking the cycle of child to parent violence and associated issues.
- 3. Breaking The Cycle Institute, Inc. shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, as amended.
- 4. Breaking The Cycle Institute, Inc. will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, as amended.

- 1. No part of the net earnings of Breaking The Cycle Institute, Inc. shall be used for the benefit of, or distributed to its members, trustees, or officers, except that reasonable compensation for services rendered, and the furtherance of the purpose of Breaking The Cycle Institute, Inc.
- 2. No substantial part of the activities of Breaking The Cycle Institute, Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation. Breaking The Cycle Institute, Inc. also shall not participate in, or intervene in any political campaign on behalf of any candidate for political office.
- 3. Breaking The Cycle Institute, Inc. shall not carry on any activities not permitted to be carried on by an organization exempt from federal tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 4. Breaking The Cycle Institute, Inc. will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1968, as amended.
- 5. Breaking The Cycle Institute, Inc. will not make any investments in such a manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, as amended.
- 6. Breaking The Cycle Institute, Inc. will not make any taxable expenditure as defined in Section 4945(d) of the Internal Revenue Code of 1986, as amended.
