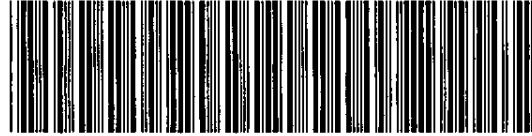

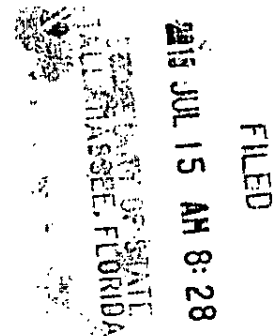

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: Name of Not for Profit Corporation

The name of the corporation shall be:

**The Foundation for Research into
Extraterrestrial Encounters, (FREE), Inc.**

ARTICLE III: Purpose

The purpose for which the Not-for-Profit Corporation is organized is:

1. **FREE** is a not-for-profit research organization that has been established by various academics, Ph.D. physicists, Ph.D. psychologists, various scientists, medical professionals, and a diversity of "Experiencers", working under one umbrella, to bring together diverse voices in the subject areas of human encounters with non-human intelligence and related "paranormal" phenomena.
2. The Mission of **FREE** will focus on "**Research, Education and Support**" but will primarily focus on scientific investigation through surveys and interviews on individuals who have had UFO related contact experiences with non-human sentient beings (commonly known as "ET Contact") and to compare this group with individuals that have had other types of "paranormal contact experiences" through the following: NDEs, OBEs, Hallucinogenic/Entheogenic natural substances, hypnotic regression, Mystical Meditation Travel, Channeling, Remote Viewing, and human encounters with non-human intelligence, and related paranormal contact experiences.

3. **FREE** will also begin, through the contributions of physicists and other scientists, to bring into our “Experiencer” research studies the latest findings from advanced physics that might be utilized to begin to explain the quantum nature of our reality. The **FREE** Board of Directors are in the process of developing hypotheses to address “paranormal contact modalities” related to the quantum nature of our multi-dimensional reality. Dr. Edgar Mitchell, Dr. Rudy Schild, among other physicists, scientists, and psychologists and other researchers associated with **FREE**, who are proponents of the **Quantum Hologram Theory of Physics and Consciousness**, will remain open and research all possible explanations in the growing field of what is commonly called “Consciousness Studies” to determine the possible interrelationship of paranormal contact modalities.

4. All **FREE** Board of Directors endorse the **Post-Materialist Paradigm of what is “Consciousness”**, promulgated by Dr. Edgar Mitchell since the early 1970s who helped to establish the Institute of Noetic Sciences (IONS), a paradigm that firmly believes that consciousness is non-local and independent of the brain. This view of non-local consciousness allows us to possibly explain a wide variety of special states of consciousness and all the so called “paranormal” contact phenomena.

5. In addition, **FREE** will also uphold the views established by the field of “**Transpersonal Psychology**” that investigates the “Spiritual” aspects of our reality with openness and to help others who have had direct personal contact experiences to integrate these experiences into their daily lives and possibly into their spiritual practice. To this end, **FREE** will continue to support all “Experiencers” of paranormal experiences through the **FREE “EXPERIENCER BUDDY PROGRAM”** and other support services.

6. **FREE** has been established to provide a working environment for scientists, lay investigators, and first-hand experiencers of non-human contact to enter into collaboration. We believe that by fostering an ongoing conversation between diverse parties, that significant advances can indeed take place. Interdisciplinary partnerships are vital for recognizing and addressing some of the most profound, but often unacknowledged mysteries that confront human society today.

7. As a Not-for-Profit Research and Educational “think tank”, **FREE** is designed to support information exchanges between those who explore alleged ET contact phenomena and associated manifestations. Those additional

manifestations, frequently classified as “paranormal”, may fall well within an expanded framework of modern physics. We therefore also support the continuing exposition of new scientific models and theories that can be utilized to clarify and unify a wide range of observations and experiences.

8. We are equally committed to upholding both the highest standards of scientific research, while maintaining a firm commitment to open-minded enquiry.

9. FREE is also committed to promoting interplay between traditional spiritual and philosophical approaches to anomalous contact phenomena and the work of contemporary science. We believe that these phenomena and the innovative new science that is exploring them are likely to propel significant social, cultural, and spiritual changes in the 21st Century; that our common ways of thinking are likely to change in very significant ways.

ARTICLE IX: 501(c)(3) Purpose Language

1. Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


2. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of State.

3. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this corporation is irrevocably dedicated to charitable, educational, and scientific 501(c)(3) exempt purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

4. No substantial part of the activities of the Not-for-Profit corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


5. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
