**Article I**

**The Name of This Corporation is: Global Christian Life Coach Commission, Inc.**

**Article II**

**The Term of This Corporation is Perpetual**

**Article III**

**Purposes**

**The general nature, objective and purposes of Global Christian Life Coach Commission Inc.**

- (a ). For the purpose of promoting, establishing, and administrating within a local Body of Believers (local church body), with all matters pertaining to fellowship, teaching, training and coaching in Market Place and Church related ministry . Membership with missionary outreach's, religious seminars, officers and directors, Church government and operation to be determined and stated in By-Laws of the corporation hereinafter authorized by these Articles of Incorporation.
- (b). To participate and conduct Christian outreaches, evangelism, training, fellowship and coaching programs.
- (c). Global Christian Life Coach Commission, Inc. shall be a wholly charitable organization.
- (d). To acquire by conveyance or inheritance – whether by gift or purchase – real property, personal property and mixed real and personal property, to be received and held in trust for the use and benefit of this corporation and its stated purposes.
- (e). To improve, invest, sell, lease, assign, mortgage, or otherwise encumber any such property, when such an action is deemed to be in the purposes as a Christian organization.
- (f). To market audio and visual productions, books, and gospels materials printed by said corporation for funding and furthering the gospel.

- (g). To operate and manage Radio and T.V. outreach and stations.
- (h). To solicit funds for each special project concerning the ministry on an organized giving plan.

#### **Article IV**

- (1) To accomplish the foregoing purposes, Global Christian Life Coach Commission, Inc. shall have corporate powers permitted under the laws of the State of Florida, including the legal capacity – as in independent entity – to enter into contracts and to prosecute and defend against any actions at law and equity.
- (2) The Corporation is specifically precluded from engaging in any Prohibited activities, as defined in Section 617.0105 of the Florida Statutes.

#### **Article V**

##### **Qualification of Members**

The membership of Global Christian Life Coach Commission, Inc. shall be limited to born-again Christians of the Spirit of God and must be a person of Christian convictions and beliefs who have been spiritually baptized in the Name of the Father, The Son, and The Holy Spirit and been accepted into membership of this organization by a majority vote of the membership of this corporation. Anyone may attend activities and functions, but membership is reserved for those who meet the requirements. A candidate for membership must believe in the doctrine of the Holy Bible, which is the belief, and doctrine of this corporation.

The member must abide by the rules and regulations placed upon them by the By-laws of this corporation and the Word of God. Membership can be terminated by proper vote of the membership majority and the Board of Directors.

- (a) Global Christian Life Coach Commission, Inc. shall train and certify, leaders, trainers and coaches for the designated purpose of this corporation and its Gospel activities.

## **Article VII**

### **Operation of Organization**

- (a) The business affairs of Global Christian Life Coach Commission, Inc. shall be managed by and under the supervision of at least (3) Directors and or Trustees as set forth in the by-laws.
- (b) Global Christian Life Coach Commission, Inc. shall have no less then three (3) officers/ directors at any-time who shall act as its Board of Directors. The number may be increased from time to time as set forth in the by-laws, but never less than three (3).
- c) Dr. Miriam Del Rio, Chairman of the board shall serve for a period of 1 year. At that time, the new chairman, namely, Bishop Dr. Lana Langston shall become chairman.
- d.) The above two positions shall be alternated every year and thereafter and for the duration of this corporation..

## **Article VIII**

### **Amendments to Articles of Incorporation**

Upon proper notice to the members of Global Christian Life Coach Commission, Inc. and the state of Florida, amendments to these Articles of Incorporation may be proposed and adopted upon 2/3<sup>rd</sup> votes of the members of the Board of Directors present at any regular meeting or any special meeting called for that purpose.

## **Article IX**

### **By-Laws**

- (a) The board of directors of Global Christian Life Coach Commission, Inc. shall provide such by-laws for the conduct of its business and the carrying out of its purposes as they may deem necessary from time to time.
- (b) Upon proper notice, the by-laws may be amended, altered, or rescinded upon 2/3<sup>rd</sup> votes of the members of the Board of Directors.

## **Article X**

### **Limitation and Dissolutions**

- (a) Global Christian Life Coach Commission, Inc. is organized exclusively for charitable,

religious, educational, training and scientific purposes, including for such purposes of the making of distributions to organizations that qualify as exempt organizations under section 501c3 of the Internal revenue Code of 1954 (or for corresponding provision of any future U.S. internal revenue law) in the event of dissolution.

(b) Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be engaged by:

1. A corporation exempted from Federal Income Tax under section 501c3 of the Internal revenue law; or
2. A corporation, contributions to which are deductible under section 170c2 of the Internal Revenue Code of 1954 of the corresponding provision or any future U.S. Internal revenue law.

In the event of dissolution of Global Christian Life Coach Commission, Inc. : The residual assets of this corporation will be turned over to a duly authorized Not-For-Profit Organization of the choice of the Board of Directors/Trustees, one that falls within the guidelines of the sections 501c3 and 170c2 if the Internal Revenue Code of 1954 or the corresponding sections of any prior or future laws.

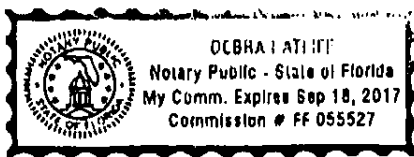
