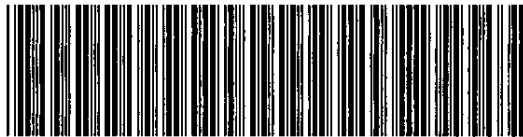

**ARTICLES OF INCORPORATION**  
**OF**  
**MUSLIM UMMAH CENTER OF FLORIDA, INC.**

We, the undersigned, with other persons being desirous of forming a *not-for-profit* corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

**ARTICLE I**

The name of the corporation shall be:

**MUSLIM UMMAH CENTER OF FLORIDA, INC.**

The address of the principal office of this corporation shall be:

**ARTICLE II**

Said corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding Sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose.

### ARTICLE III

Management of the Corporation shall be vested in the Corporation's Board of Trustees whom are the Officers. The number of Trustee Officers shall not be less than three and no greater than twelve. Any action required or permitted to be taken by the Board of Trustees, under any provisions of the law, may be taken without a meeting, if at least two thirds of the Trustee's shall individually or collectively consent in writing to such action. Such written consent shall be filed with the minutes of the proceedings of the Board of Trustees. Any such action by written consent shall have the same force and effect as if taken by a unanimous vote of the Board of Trustees. Any certificate or other document filed, under any provision of the law which relates to the action so taken, shall state the action was taken by the unanimous written consent of the Board of Trustee in a meeting or without a meeting, and that these Articles of Incorporation authorize the Board of Trustees to so act. Such a statement shall be prima facia evidence of such authority. Any new project or projects, construction of such projects, and the securing of financing for such projects, will be handled by a Trustee. Collecting of funds and spending of those funds will be handled by a Trustee. Selection of project related architects, engineers, builders, etc. will be performed by a Trustee. The Imam can only be hired or terminated by a vote of at least two thirds of the Trustee's whom individually or collectively consent in writing to such action.

#### ARTICLE IV

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

#### ARTICLE V

This corporation is to exist perpetually.

#### ARTICLE VI

The Corporation shall have the power to acquire, own, maintain and use its assets for the purposes for which it is organized; to raise funds by any legal means for the encouragement of its purposes; to acquire, hold, own, use and dispose of real or personal property in connection with the purposes of the Corporation; to exercise all powers necessary or convenient to the furtherance of the purposes for which the Corporation is organized: and to exercise all powers granted to a corporation *not-for-profit* under Florida law. In addition to the powers specified, the Corporation shall have the additional powers as specified in its bylaws, in furtherance of the purposes set forth in ARTICLE II hereof.
