



Article of Incorporation

Of

Business and Educational Assistance for Tomorrow, INC.

We, the undersigned, pursuant to Chapter 617, Florida Statutes, have associated ourselves together and do hereby associate ourselves together, for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit, and adopt the following Articles of Incorporation.

Article I- Corporate Name

The name of this Corporation is: Business and Educational Assistance for Tomorrow, INC.

Article II- Terms of Existence

This Corporation shall have perpetual existence commencing upon the filling of these articles.

Article III- Nature of Business and Powers

The principal nature and purposes for which this corporation is organized are:

- a) To assist adolescent, adult and elderly person, including indigent minorities, to develop their potential by aiding in scholastic training, tutoring, education and promotion of special production and classes, with emphasis on immigration causes, legal and financial issues.
- b) To provide a forum for adolescent, adult and elderly person, including indigent minorities, regardless of race, creed or color to obtain scholastic training, tutoring, internships and guidance in the pursuit of their education and careers, with particular emphasis on immigration causes, legal and financial issues.
- c) The corporation shall be empowered to publish newspapers, pamphlets, books and magazines; acquire, rent, lease, let, hold, own, buy, convey, mortgage, bond, sell or assign property; real, personal, or mixed; as the purposes of the corporation whether express or implied shall require, associate itself with other persons, corporate or natural, for the purpose of becoming a member of an in other wise associating itself with other corporation or association of similar or like nature; collect dues, fees, rents, fines, subscriptions and other revenues to the advantages of the corporation and to do and perform all such other acts and things, including those generally allowed by the laws of the State of Florida relative to corporations not for profit, as now existing, or as the law may henceforth provide, as form time may be necessary or expedient in the exercise of any and all of its corporate functions, power and rights.
- d) The promotion of a better understanding amongst the different groups of people in the American community.
- e) To do and perform all such acts and things, including those generally allowed by the laws of the United States and the laws of the State of Florida relative to corporations not for profit, as now

existing, or as the law may henceforth provide, as from time may be necessary or expedient in the exercise of any and all of its corporate functions, powers and rights.

Article IV- Membership

Theses members of this corporations shall be subscribers, and such other persons as may from time to time be elected to membership by the members of the corporation.

Article V- Board of Directors

There shall be four (4) members of the initial Board of Directors of the Corporation. The directors shall be appointed every two (2) years by majority vote. The number of directors may be increased or diminished from time to time by the Bylaws adopted by the membership, but shall never be less than one.

Article VI- Initial Directors

Article VIII- Liquidation

Provision for the regulation of internal affairs of the Corporation, including the distribution of assets upon dissolution of final liquidation shall require that:

The assets of the corporation shall be dedicated to the purposes hereinabove stated.

Upon dissolution or final liquidation, such assets shall be distributed by operation of law.

Article IX- Registered Agent and Principal Office

Article XII-Income Distributions


