Articles of Incorporation of Team Daniella's Foundation, Inc.

Article I. The name of the Corporation shall be: Team Daniella's Foundation, Inc.

Article II. The principal place of business and mailing address of the corporation is: 441 Minola Drive, Miami Springs, Fla. 33166.

Article III.

- A. Said Corporation is organized exclusively for charitable, religious, educational, and scientific, literary purposes, testing for public safety, preventing cruelty to children and animals, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501©(3) of the U.S. Internal Revenue Code, or corresponding section of any future federal tax code. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in (including the publishing or distribution of statements), or intervene in any political campaign on behalf of or in opposition to any political candidate.
