# Articles of Incorporation - Addendum GIVING HEARTS WITH LOVE FOUNDATION, INC.

#### ARTICLE IX – DISSOLUTION OF THE ORGANIZATION

- a. Giving Hearts with Love Foundation, Inc. is organized exclusively to provide an array of programs, services, and activities that support and assist families to enhance their health and wellbeing, and improve their quality of life. The Purpose and Mission of the Giving Hearts with Love Foundation, Inc., is to provide food, clothing, basic needs, health and wellness, services, activities, and programs, designed to benefit and uplift individuals and families in South Florida and around the world. Programs, services, and activities may include support from, receipt of, and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal revenue code, or corresponding section of any future federal tax code.
- b. No part of the net earnings of the organization shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof. No substantial part of the activities of the organization shall include the distribution of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for political office. Notwithstanding any other provision of this document, Giving Hearts with Love Foundation, Inc. shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c)(3) of the Internal revenue code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductable under section 107 (c)(2) of the Internal revenue code, or corresponding section of any future federal tax code.
