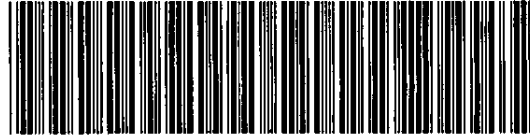

Article IX Disposition of Property:

The corporation is not organized for profit, and no part of the net earnings of the corporation shall inure to the benefit of any member or individual. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)3 of the IRS code, with preference given to boxer rescue organizations.

No member of the Sunshine Boxer Rescue Board of Directors or Officers shall derive any personal profit or gain, directly or indirectly, by reason of his or her participation in Sunshine Boxer Rescue. Each individual shall disclose to Sunshine Boxer Rescue any personal interest he or she may have in any matter pending before the organization and shall refrain from participation in any decision on such matter. Any member of Sunshine Boxer Rescue's Board of Directors or Officers shall refrain from obtaining any list of Sunshine Boxer Rescue's clients for personal or private solicitation purposes at any time during the term of their affiliation.
