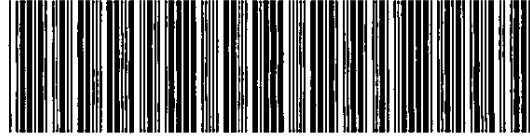

**Articles of Incorporation  
of

The undersigned, desiring to form a non-profit corporation under the non-profit corporation law of **Florida**, do hereby certify:

**Article I:** The name of the corporation shall be **Panama City Ski & Travel Club, Inc.** The period of duration of the corporation is perpetual.

**Article II:** The physical and mailing address in this state where the principal office of the corporation is located is the City of **Panama City, Bay county**.

**Article III:** Said corporation is organized for the purpose to develop, promote, establish and coordinate programs of education and events of the highest quality for the safe enjoyment by the membership of the sport of snow skiing, other winter and snow related sports activities and travel for pleasure and recreation; substantially all of the activities of which are for such purposes and no part of the net earnings of which inures to the benefit of, or be distributable to any member, trustee, officer, director or other private person.

**Article IV:** The name and address of the Director and President of the corporation is:

**Article V:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be for the carrying on of or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not in any substantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation or prohibited by law.

**Article VI:** No officer or director of this corporation shall be personally liable for the debts or obligations of **Panama City Ski & Travel Club, Inc.**, of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

**Article VII:** The Board of Directors shall be elected in a manner described in the corporation's bylaws and shall take office on May 1 after the annual meeting at which they are elected.

**Article VIII:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt

purposes. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for exempt purposes.
