# ***Amended Articles of Incorporation Of Support The Children and Family Community Development, Corp.***

The undersigned subscriber to these Articles of Incorporation, desiring to form a Not-For-Profit Corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

## ***Article I. Corporate Name***

The Name(s) of this Corporation shall be:

***Support The Children and Family Community Development, Corp.***

***Principle Address: 1800 Forest Hill Boulevard, Suite B8  
West Palm Beach, Florida 33406***

## ***Article II. Terms of Existence***

This Corporation shall have perpetual Existence.

## ***Article III. Purpose and Powers***

Said Corporation is organized exclusively for charitable, religious, scientific, and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 ( c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code. To instill self reliance, self sufficiency, spiritual and moral uplift, and medical care for those in need especially children who have been abandoned, displaced and/or orphaned. To serve the community-at-large. To present a set of programs, projects, services, seminars, lectures pertaining to the socioeconomic development for those families in need. To provide enhanced educational experiences, educational tuition, housing, feeding and medical care to children and families both in the United States and in Haiti. To provide programs, projects and services for youth aging out of foster care.

No part of the of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers and other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 ( c)(3) purposes.

No substantial part of the activities of the Corporation shall be in carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to any candidate for public office.

Notwithstanding any other provision of the Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501 ( c)(3) of the Internal Revenue Code, or corresponding section of any further Federal tax code.

Upon dissolution of this Corporation, assets shall be distributed for one or more exempt purposes with the meaning of Section 501 ( c)(3) of the Internal Revenue Code, or corresponding section of any further Federal tax code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose.

### ***Article IV. Capital Stock***

There will be no capital stock in this corporation.

### ***Article V. Initial Capital***

The initial capital with which this corporation may be in business shall not be less than One Hundred Dollars (\$100.00).

### ***Article VI. Directors***

This Corporation shall one Executive Director initially and two other respective Directors who were elected through parliamentary procedure. The number of directors may be increased or diminished from time to time by the Bylaws of the Corporation.

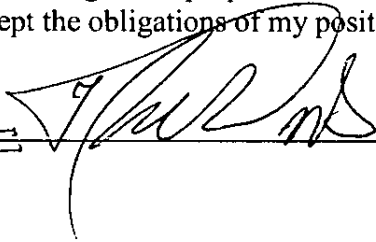

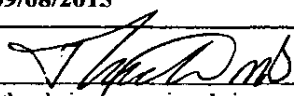
