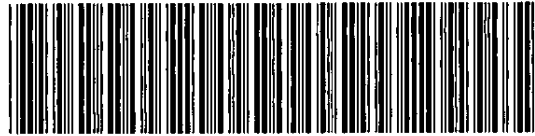

ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: **Mothers of Men Incarcerated, Inc.**

ARTICLE II PRINCIPAL OFFICE

Principal street address and mailing address is: 7918 SW 103rd Loop, Ocala, Florida 34476.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

A) This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. In addition, this organization shall provide assistance, legal help, and other support to mothers whose children are incarcerated.

B) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III (A) hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article IV – Duration

This corporation shall have perpetual existence.

ARTICLE V - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected and appointed:

At each annual meeting the members the corporation shall elect Directors to hold office for an initial term of one year. Each Director shall hold office until the expiration of the term for which elected, or until a successor has been elected and shall have qualified, or until resignation or removal.
