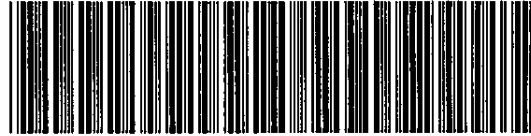



**AMENDMENT TO ARTICLES OF INCORPORATION
OF
MILLENNIA FOUNDATION, INC.**

Article III: Purposes and Powers

3.1

B. Purposes. The Corporation is organized and shall be operated exclusively for charitable, religious, educational, scientific, literary, testing for public safety, fostering national or international amateur sports competition, and preventing cruelty to children or animals, including, but not limited to, for such purposes the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code (the "Code") or the corresponding section of any future federal tax code.
