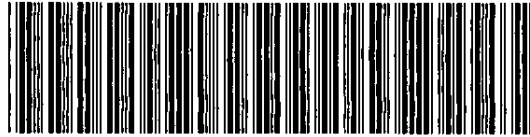

ARTICLES OF INCORPORATION
OF

Iglesia Pentecostal El Arca del Pacto, Inc.

(NOT FOR PROFIT)

We the Undersigned personal of state Florida all of whom are of legal age, each being competent to contract, hereby from ourselves and our successor into a corporation not for profit under the Law of the State of Florida, and adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of this corporation shall be: Iglesia Pentecostal El Arca del Pacto, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 220 Fairlane Ave. Orlando, Florida 32809

ARTICLE III PURPOSES

The general nature, object and purpose of this corporation is as follows:

A. The main and specific purposes for which this corporation is formed are to maintain and operate a religious corporation and to propagate and disseminate the religious principles that comprise: : Iglesia Pentecostal El Arca del Pacto, Inc.

B. The general purposes and objects for which this corporation is formed are to operate exclusively for charitable, religious and educational measures, to include but not limited to the following:

1. Establish, maintain and conduct an appropriate organization to oversee the affairs of this corporation.
2. To license and ordain ministers of the Gospel and missionaries to advance the work of this corporation in the United States and all other foreign countries, according to the regulations to be promulgated by the Board of Directors.
3. Assist in the establishment and / or give the corporation of churches or religious bodies for the dissemination and propagation of the Gospel of Jesus Christ in the United States and other foreign countries, such churches and entities subject to the articles and bylaws established by the corporation: : Iglesia Pentecostal El Arca del Pacto, Inc.
4. To establish, own and operate schools at the university level or a lower level.
5. Establish, maintain and conduct outreach efforts to advance the gospel in the United States and all foreign countries, pursuant to regulations promulgated by the Board of Directors.
6. Make any and all actions or things necessary, appropriate or desirable for the Compliance with any purpose or to achieve one or more objectives specified herein or that at any time appear conducive to that, or dossiers for that, if not Inconsistent with provisions or any law that may apply to the fulfillment of such Achievement of the purposes or objectives.

It is intended that the foregoing objects and purposes of this article shall not unless Specify here, will in no way limited or restricted by reference or inference from the terms of any provision of this or any other item in these articles of incorporation, but the objects and purposes specified in these items will be taken a statement from general objects and purposes and not intended to limit the activities of this corporation as charitable, religious and educational.

ARTICLE IV POWERS

Iglesia Pentecostal El Arca del Pacto, Inc. will and exercised all the rights and powers conferred on corporations under the laws of the State of Florida, provided that this corporation has no authority to engage in any activity other than to advance objects and purposes set forth in Article III.

ARTICLE V NO FINANCIAL PROFIT OR MONETARY GAIN

Iglesia Pentecostal El Arca del Pacto, Inc. is not organized, or be operated for profit or pecuniary gain, and includes the distribution of goods, or dividends to members, as this organization are formed non-profit. The property, assets, and net earnings of this corporation are irrevocably dedicated to religious, scientific and charitable and any gain or net inflow of this corporation shall be to the advantage or benefit of any director, officer, and member or for the benefit of private shareholders or individuals. With the dissolution or closing liabilities of the corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious, charitable, scientific or which has established its tax exempt status under Section 23701 (d) of the Code of Internal Taxes. If this corporation has any assets in deposits, such property shall be distributed according to the decrees of the Superior Court of the County within which the principal office of this corporation is located, at the request for that at the attorney general or by any person interested in the settlement.

ARTICLE VI LIMITATION OF ACTIVITIES

Iglesia Pentecostal El Arca del Pacto, Inc. not conduct propaganda as a substantial part of its activities, or attempt in any way influence the legislation. This corporation shall not participate in or intervene in (including publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

ARTICLE VII DIRECTORS / OFFICIAL MINISTERIAL MEETING

The official in charge of managing the affairs of this corporation shall be: President (Pastor) Secretary, Treasurer and deacons. The President shall be appointed by : Iglesia Pentecostal El Arca del Pacto, Inc. President shall hold office indefinitely unless for cause of immorality that goes against our ecclesiastical principle. The governing body can then expel that corresponding tests are validated under an administrative court where the member of the board will meet behind closed doors to the safety of the corporation and avoid any scandal affecting our company and fellowship of our organization. The position of secretary, treasurer and deacons may be transferred if it is then required that the joint ministerial approval under the rules and laws of the ecclesiastical ministry.

ARTICLE XI MEMBERSHIP

Membership shall be open to anyone willing to comply with the corporation bylaw, however, neither the incorporates nor the members shall have any vested right, interest, or privilege of, in or assets function, affair or franchises of this corporation, or any right, interest or privilege which may be inheritable, or shall continue after his/she membership ceases in the forenamed corporation. The corporation shall not have the power to buy, mortgage sell encumber of deed or dispose of any property which it may acquire, without the consent or the direction of two-thirds (2/3) majority vote of the members, or its successors. 


