# ARTICLES OF INCORPORATION FOR ROTARY CLUB OF FORT LAUDERDALE/CYPRESS CREEK CHARITABLE FUND, INC. (Not-For-Profit)

The undersigned, desiring to form a charitable corporation under Chapter 617, Florida Statutes, as amended, the Florida Not for Profit Corporation Act, does hereby adopt the following Articles of Incorporation and certify:

#### ARTICLE I

The name of the corporation shall be ROTARY CLUB OF FORT LAUDERDALE/CYPRESS CREEK CHARITABLE FUND, INC.

## ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1761 W. Hillsboro Boulevard, Suite 205, Deerfield Beach, Florida 33442.

#### ARTICLE III PURPOSE

The corporation is organized exclusively to promote religious, scientific, literary, educational, and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, either directly or through other religious, scientific, literary, educational, or charitable organizations.

The corporation is formed mainly to act as a supporting organization to support the charitable purposes of The Rotary Club of Fort Lauderdale/Cypress Creek, Inc., a Florida not for profit corporation.

#### ARTICLE IV MANNER OF ELECTION

The method of election of directors is as stated in the bylaws.

At all times there shall be at least two members on the Board of Directors who simultaneously serve on the Board of Directors of The Rotary Club of Fort Lauderdalc/Cypress Creek, Inc., a Florida not for profit corporation.

#### ARTICLE VI MEMBERS

The qualification for membership, if any, in the Corporation, and the manner of admission of members, if any, shall be as stated in the Corporation's Bylaws.

### ARTICLE VII EARNINGS AND ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3). No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(e)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(e)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE VIII DISSOLUTION

This Corporation is not for profit and, therefore, there shall never be distributed any gains, profits or dividends to any officer, director or member of the Corporation, and no part of the net earnings shall inure to any individual. It is a further express provision of these Articles that the assets and proceeds of every nature and description of the Corporation are, and shall forever be, irrevocably dedicated to the benevolent purposes stated in Article III hereof. In the event of liquidation or dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all assets of the Corporation to any exempt organization(s) under Section 501(c)(3) as the Board of Directors shall determine.
