ARTICLES OF INCORPORATION

OF

JAYE SQUARED YOUTH EMPOWERMENT SERVICES, INC.

(A Corporation Not for Profit)

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be:

JAYE SQUARED YOUTH EMPOWERMENT SERVICES, INC.

<u>ARTICLE II -- PRINCIPAL OFFICE</u>

The principal place of business and mailing address of the Corporation is:

ARTICLE III - PURPOSE

The Corporation is organized exclusively for religious, charitable, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income taxes as an organization described in section 501 (c)(3) of the Internal Revenue Code, (or corresponding section of any future federal code).

The Corporation strives to introduce engineering and architecture principles, develop social/emotional skills, empower youth by enhancing self-esteem through solving problem and completing projects, and increase general knowledge through discussions related to various models.

<u>ARTICLE IV – EXEMPTION REQUIREMENTS</u>

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.
- 2.) No substantial part of the activities of the Corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the Corporation shall not participate in, or intervene in (including by

- publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3.) Notwithstanding any other provisions of this document, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code, or by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future tax code.

ARTICLE V - MEMBERS

The Corporation shall have one class of members. The rights and privileges of all members shall be equal. Each member shall be entitled to one and only one vote on any matter submitted to the membership for vote.

ARTICLE VI - BOARD OF DIRECTORS
