The undersigned President of Arise for Families, Inc., a not-for-profit Florida corporation, document number N15000007983, hereby certifies that the following action was taken upon the unanimous written action of the Board of Directors and the members of the corporation on \underline{W} \underline{G} , 2019, in lieu of holding meetings thereon:

The Articles of Incorporation are hereby amended as follows:

Article IV is hereby amended and restated in full as follows:

ARTICLE IV

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code. The purposes of the corporation shall be the following, to the extent that the following purposes are within the foregoing definition of charitable, religious, educational or scientific purposes:

The corporation is dedicated to helping families succeed. We shall seek to educate, empower and encourage refugee families to achieve sustainability during the process of resettlement and in refugee camps by: engaging refugees in a mentoring partnership with established professionals; offering educational services and programs to foster sustainability; connecting refugees with job placement services; and providing assistance with housing.

The corporation shall seek to strengthen marriages and family units through interaction, training and hands-on service projects.
