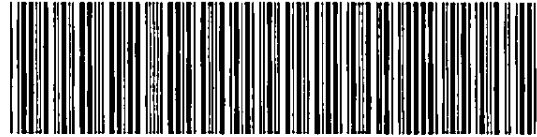

OF ALL THE LIABILITIES OF THE CHURCH, DISPOSE OF ALL THE ASSETS OF THE CHURCH EXCLUSIVELY  
FOR THE PURPOSES OF THE CHURCH IN SUCH A MANNER, OR TO SUCH ORGANIZATION OR  
ORGANIZATIONS ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL,  
RELIGIOUS OR SCIENTIFIC PURPOSES AS SHALL QUALIFY AS AN EXEMPT CORPORATION OR  
ORGANIZATION UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED  
(OR OF THE CORRESPONDING PROVISIONS OF ANY FUTURE UNITED STATES REVENUE LAW) AS THE  
BOARD OF DIRECTORS SHALL DETERMINE.
