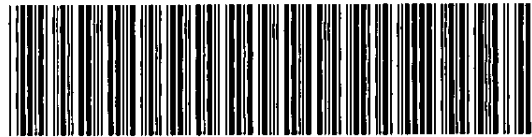

The purpose for which the corporation is organized exclusively for Religious,
charitable, and educational within the meaning of section 501c3 of the
internal revenue code of 1986 or the corresponding provision of any future
United States Internal Revenue law.

No part of the earnings of FOUNTAIN OF RESTORATION TITLE I COMMUNITY
DEVELOPMENT CENTER, INC, shall inure to the benefit of/ or be distributable
to, its members, directors, officers, or other private persons except that the
Corporation shall be authorized and empowered to pay a reasonable
compensation for services rendered and to make payments and distributions
in furtherance of the purposes set forth in these articles of incorporation.

Notwithstanding any other provision of these articles, FOUNTAIN OF
RESTORATION TITLE I COMMUNITY DEVELOPMENT CENTER, INC., shall NOT
carry on any propaganda or otherwise attempting to influence legislation, and
the corporation shall not participate in or intervene (including the Publishing
or distribution of statements) and any political campaign on behalf of or in
opposition to any other activities not permitted to be carried on (a) by a
Literary, Charitable, Scientific and Educational not for profit corporation
exempt from federal income tax under Section 501 (c) (3) of the Code of 1986
or (b) by a corporation, contributions to which are deductible under Section
170 (c) (2) of the Code.

DISTRIBUTION UPON DISSOLUTION

Upon the dissolution or winding up of FOUNTAIN OF RESTORATION TITLE I
COMMUNITY DEVELOPMENT CENTER, INC can only be done by the express will

of the Executive Board of Directors, decree of Court, or bankruptcy. In such a case, all efforts shall be terminated and all assets shall be liquidated in order to satisfy creditors. Any remaining assets will be donated to other not for profit corporations that are exempt within the meaning under section 501(c)3. Any such assets not disposed shall be distributed by the Superior Court in the county which the Corporation reside to a not for profit corporation which has established its tax exempt status under the internal Revenue Code section 501c3.

ARTICLE IX Authority of the Corporation

The Executive Board of Directors shall sole power to adopt, amend or repeal By-Laws for the management of this corporation, and the duties of the officers of this corporation shall be prescribed by such By-Laws.

ARTICLE X AMENDMENT


These Articles of Incorporation may be amended in the manner provide by the laws of the State of Florida.
