Articles of Incorporation of

JPI - Just Paws Incorporated

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: It is all lawful purposes including, but not limited to, the preservation and protection of endangered animals, prevention of cruelty to all animals, educating the public in regards to endangered animals and the enlightenment of the general public regarding avoidance of cruelty to animals and their mishandling and establishing a low cost food program enabling sanctuaries to obtain affordable food for their animals.

No part of the net earnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set fortherein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall national participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.
