ARTICLES OF AMENDMENT  
TO

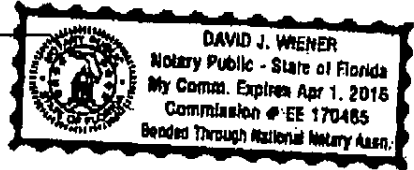

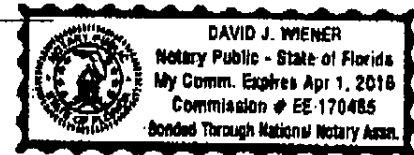

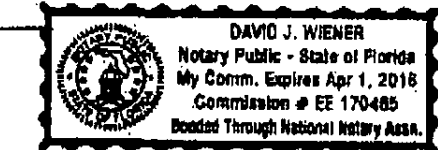
